The main purpose of the job is to support the regulatory team on technical and scientific aspects related to industrial risk management. The Industrial Hygienist will support the REACH manager on technical input into exposure and use scenarios in the REACH files, and will provide technical and scientific support on topics related to occupational exposure, ambient air standards etc. Tasks and responsibilities include, but are not limited to:

- Providing input and advice to the Members of the Nickel Institute and downstream users, with respect to workplace legislation and protection of workers, exposure to nickel and nickel compounds, methods to measure workplace exposure, speciation, particle size distribution, etc.
- Attending meetings related to exposure scenarios and providing advice regarding description of processes.
- Liaising with external consultants.
- Providing support on other regulatory developments where expertise on use and exposure in applications is needed and interacting with regulatory authorities on those topics.
- Managing regulatory and technical developments with respect to workplace legislation and ambient air standards at global level.
- Participating in meetings of Eurometaux and the ICMM related to development of technical and scientific tools for metals and metal compounds in close cooperation with the science department.
